





Raising of La Gogue Dam

Loan for USD 21 million has been signed with AFDB. Consultant for the project has been appointed and currently he is evaluating the design prepared by GIBB. PUC is currently in the process of recruiting a suitably qualified firm to undertake project supervision and following this the construction contract will be put on open tender, expected around end of this year. Construction work is expected to start early next year.

Non Revenue Water

Using its own resources PUC has managed to bring down non revenue water (NRW) from 55% about 3 years ago to 38% level presently. The target is 30%. In addition, a firm has been recruited to assist PUC to accelerate the implementation of the NRW program.

Water Transfer Mare Aux Cochons and Le Nirole

Levelling and other design works are in progress on this project. Construction works are expected to start later this year.

Sanitation

Design works are in progress on the La Digue sewerage system. Construction works are expected to start end of 2016 and will take 18 months to be completed. Work to extend coverage of the B Vallon sewerage network started last year and will continue for the foreseeable future. Some 81 additional households have already been connected to the sewer system.
